

It has come to my attention that Halleluyah Scriptures, Deb and Ken Wessel/Allen, with the full support of Alan Horvath, have come together to produce a statement in response to our website. I have two messages for them.

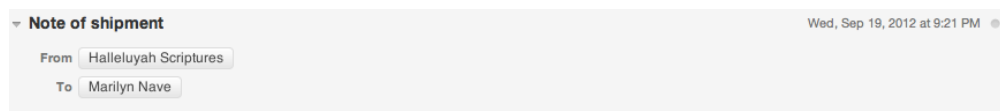
To Deb and Ken, "Satan has so filled your heart and you are lying to the Ruach. YHWH will judge you both."

To Alan, "Shame on you for not searching out the matter. You have provided no proof of any claims you have made....not one single document. Woe to you who call evil good and good evil. This will not turn out well for you."

I am going to set some matters right and so will Ted. I will attempt to only show my evidence of the continuing lies and Ted can show his. For the purposes of understanding, HS quotes are in blue and my responses are in black. The picture files are a screenshot of my email conversations with Halleluyah Scriptures, "Shalom" at the time.

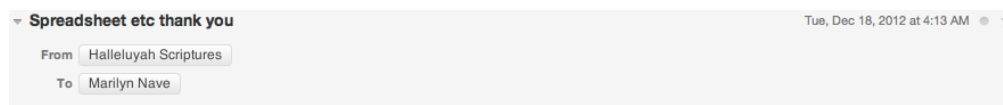
"There is much that Mr. Ramp does not know regarding this project simply because he only served for such a short period. The same goes for the other volunteer who served for only 6 weeks before giving up.

Just so I can set the record straight, Deborah is referencing me as "the other volunteer" and my start date was right after receiving this shipment talked about in the email below (notice the date) and my end date was shortly after the date of the second email.



Shalom Sister,

Just talked with Nance the postal agent and we are working to get the shipment to you soon. She is arranging help. What will need to happen at your end is some helpers to unload as there is no tail lift as it will cost 1400 to have it and it should only take a little over an hour to unload the truth with the driver.



Hi Marilyn,

When you have finished with the orders can you kindly email me the spreadsheet of orders as well as to Ted so I can check things if anyone emails as they usually do daily.

"Mr. Ramp and his wife came to help the HalleluYah Scriptures project as postal agents and accountant for a short period of 10 weeks. They set up a corporation under the HalleluYah Scriptures name and self-appointed themselves as President and Secretary respectively using a long-term team member's name fraudulently (without his knowledge or permission) and is going to be dealt with by that person in the proper forum."

As I stated in my testimony, I started the process of setting up a corporation and then cancelled it. This process was then begun by the Ramp's. As you can read from the screenshot of the emails below sent to me, Ted and Robin Ramp were acting upon the instructions of HS and not self-appointed as Deborah claims. Alan Horvath is the "long-term" team member referenced here and Ted was instructed to put him on as Vice President with Alan's full knowledge.

On Tue, Dec 4, 2012, at 02:33 PM, Marilyn Nave wrote:

Order to set up tax id had to be cancelled, could not be transferred. Refunding \$\$\$ to card. They said to call the 800 number to restart the way you want this set up. You can call and talk to them or have the accountant call.

“The Ramps were never appointed by the HalleluYah Scriptures project to set up a corporation where they were in total control and we were not aware of it until he emailed his resignation.”

This second email calls attention to more lies stated by HS. Indeed, Ted and Robin transacted on behalf of HS at their request, with their full knowledge and instruction.

They have done this and it cost 30.00 they by passed this group and filed it themselves so that saved money HalleluYah

Moreover, their support by those who sell the Word is quite telling. Sadly, these people are drawing false conclusions based on scanty so-called "facts" and documents which they know about and/or have from the very short period of time which they served HalleluYah Scriptures ... but their ideas are far from the truth and are only misleading innocent people.”

A few weeks after resigning from HS, I received this threatening email from Deborah. At the time, I was unsure what led to her delusions but since putting up this site, I have discovered what triggered her anger. She had read on Nazarene Space, a comment that a previous volunteer had revealed their names, Shalom and Max Weiss, and she assumed it was me. At that point, however, I knew they were not Shalom and Max and I called her by her real name “Deborah”. The Ruach was continuing to reveal their deception and I wanted her to know that I was on to their sham as you will read in my responses. I had not talked to anyone other than Nance and Erik at the timing of her email. It was not until we launched this site that any of us talked to ISR or Bill Meyer.

It has come to our attention that you are sharing information about this project. We have a signed contract from you and your husband the first we have ever had to do with anyone.

With the information you have shared we will take action. We have all the information that is needed plus a lot more. Marilyn this is not the first time you have had problems with others in ministry and we are well aware of them. If you do not stop what you are doing then we will proceed.

We both agreed to move on but this has not been the case with you. We do not hold any bitterness for the 8 weeks you tried to help as we use our time wisely for the Father.

We ask you to please do not share anything about this project as stated in the contract or you leave us no alternative. We will be keeping all the information you have shared with others and will forward it onto our Lawyer. Any or all information shared with you is private as per the contact. Please take your problems to the Father and have Him deal with it.

We will not be reading any of your emails as you said in your last email - Final.

My first response and then it went on from there.

You are free to take what ever action you think will do you any good. You are free (obviously) to act any way you want to act but that does not make it right. You can threaten all you want and your threats mean nothing to me because I follow what my Father tells me to do and the results are in His hands.

I signed no such non disclosure and agreed to nothing of the sort. What I signed is ambiguous at best and "project" related and the wording makes it clear that you sought NO legal council anyway. It makes no determinations about people working on the project. No one on "the team" has given me information about anyone else on "the team". Any information I have has been given to me by the leading of the Ruach.

What you need to do at this point, is realize your sin and fall to your knees in repentance. EVERYTHING will be revealed and everything will come into the light as it is His desire and His Torah. YOU are blaspheming His name by your testimony. So, if I were you, I would put my every waking moment into begging our Father's forgiveness and asking Him to cleanse you rather than sending me threatening emails that mean very little. I do not fear you. I fear YHWH and I will do as His word tells me to do as I have done all along.

Despite what you think, my prayer is for your restoration.....but it is for the restoration of your soul, not your "project". You have it all backwards. YHWH is not interested in your project and He certainly doesn't need you or me to accomplish His will. He is interested in your sanctification and your testimony to others. Both, in this case, are in question and I am speaking bluntly to allow you an opportunity to come clean before all of this blows up. Make no mistake, Debra, this will ALL come out regardless. If not by me, then by others who are prepared to confront it as well.

Forgiveness is waiting for you but not before repentance.....never before repentance. I am speaking about our Father's forgiveness and cannot promise the same of man. Whether men forgive you or not is between them and their Savior, but it is commanded. I would hope that others would be more willing to submit to Torah than you have in this situation.

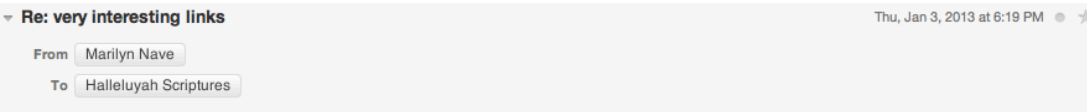
